Dear Friends,

For Bridging Bionics, 2021 marks our fifth full year of delivering much-needed programming to help individuals with neurologic mobility impairment live healthier, more productive lives. It also represents the first full year since I assumed the Board President position. It was a year of challenges and inspiring mission success, made possible by the generous support of our donors, partners and sponsors.

Since 2015, BBF has earned donor trust through adherence to nonprofit best practices for high impact and sustainability. Our website includes information publically disclosed to enable easy review of operational practices, financial results and commitment to ethics and transparency. WE achieved Charity Navigator's GIVE WITH CONFIDENCE rating from with an 80-point score, reflecting over 80% of funds for direct programming and full compliance with accountability information.

BBF is a young organization, ready to mature by incorporating a multi-year strategic plan to guide activities for sustainability. This formalized plan will be shared publically once complete. One of the first strategic tactics we undertook is to receive a full 100-point score by Charity Navigator for 2021. This requires completing a formal financial audit at an expense of \$8,000. We believe the expense appropriate as we work to expand impact and continue to earn your trust in supporting our mission.

On behalf of the Board of Directors I want to thank each and everyone one of you who believes in what we do enough to support our efforts with your time, talent, and treasure.

Case for Support

Our Programs: Providing Affordable Access to Health

The goal of our neuro-rehabilitation program is to provide ongoing access to mobility augmenting technology for individuals with neurological mobility impairments for the purpose of rehabilitation and health maintenance.

Regular exercise therapy sessions are instrumental in maintaining health, reducing secondary complications from paralysis, enhancing functional neuro-recovery and improving overall quality of life. This capability is only possible through advanced assistive technology which compensates for lost motor function.

Without BBF, the cost per individual for regular exercise therapy utilizing advanced technology to augment lost mobility would exceed \$25,000 annually, making it cost prohibitive for almost all individuals in need.

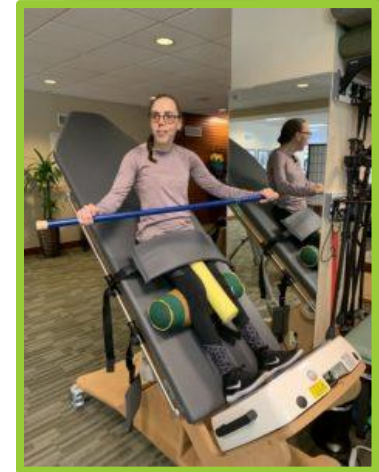

Case for Support

Our Results: Improving Physical & Emotional Wellbeing

- ▶ The BBF program supported on average 50 clients per week in 2021, an increase from 45 clients in 2020.
- ▶ BBF provided 2,925 program sessions in 2021, averaging 56 sessions per week, or 11 sessions per day, from our two programming locations. This is a significant increase from 2020, which averaged 8 sessions per day.
- ▶ 80% of clients reported improved physical health as a result of exercise therapy sessions.
- ▶ 90% of clients reported improved emotional health as a result of exercise therapy sessions.

Our Impact

- ▶ **>\$825,000** invested in therapy sessions
- ▶ **>\$750,000** invested in technology equipment
- ▶ **>11,000** mobility sessions gifted
- ▶ **>100** program clients served, from 3 to 90 years of age
- ▶ **>75** months of continuous programming

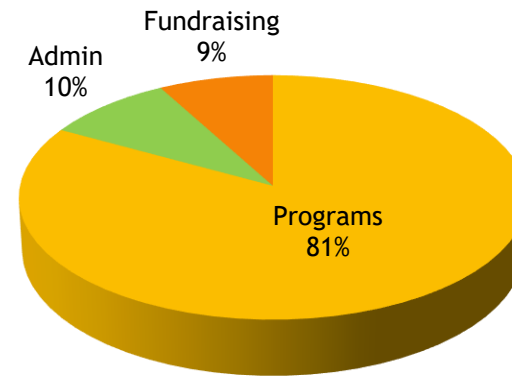
