We are excited to announce that through the gracious assistance of Anne and Michael Spellings, we have secured a long-term home for our much-needed mobility program. Our lease at 2605 Dolores Way, Carbondale, CO begins in July 2024 with an open end-date. We extend our heartfelt thanks to the Spellings family who stepped-up to invest in this property for the sole purpose of supporting Bridging Bionics for now and the future.

This new space will serve as our primary facility, as we transition from the Snowmass Club property we have enjoyed since 2016. Our goal is to make the Carbondale space a permanent home for BBF by raising the funds needed to own the property outright.





OUR NEED FOR A PERMANENT FACILITY


We currently operate from two locations, one in Snowmass Village and the other in Glenwood Springs. With the lease agreement at the Snowmass Club ending December 31, 2024, combined with an expanding equipment inventory, and an increase in client demand, we determined we needed to obtain a larger space with a long-term ownership.

The warehouse space at 2605 Dolores Way will readily meet our immediate needs and can become our primary neurorehabilitation center for the future. We plan to maintain our space at Midland Fitness in Glenwood Springs to better serve clients along the I-70 corridor from Grand Junction to Avon.




The new Carbondale property includes 1,824 square feet of warehouse space with a welcoming, open floor plan and high ceilings necessary for our equipment. Further features include a large, ADA accessible bathroom, large overhead garage door to make equipment move-in easy, and lots of natural light. The move-in ready interior requires minimal build-out costs to add a comfortable reception area, a small kitchenette, and ample storage. The ADA parking near the front entrance and the central mid-valley location near Hwy 82, with easy access to RFTA Transportation and the Rio Grande Trail, make the space ideal for our permanent home.








MINIMAL BUILD OUT


The open floor plan will be more conducive to our team members working concurrently with BBF athletes.






OUR IMPACT
